





Climate changes will cause an increase in vectors and epidemics due to natural disasters (Ministry of Health 2019-2023 Strategic Plan). The starting point of Turkey's climate and health policies is 2010. "National Program and Action Plan on Reducing the Adverse Effects of Climate Change on Health" was approved on 21 January 2015.



Scope of National Program and Action Plan on Reducing the Adverse Effects of Climate Change on Health

- Reducing the impact of extreme weather events (excessive precipitation, extremely hot and cold weather, air pollution) and the resulting natural disasters (flood, fire, etc.) on human health and social life.
- Strengthening the institutional infrastructure for the follow-up of the diseases seen and/or increasing in our country as a result of climate change, increasing the cooperation with inter and intra institutions.
- Ensuring water and food security, struggle against diseases arising from water and food.
- Carrying out necessary studies to prevent vulnerable groups from being affected by the adverse effects of climate change.
- Reducing the adverse contributions of health institutions to climate change
- Raising public awareness for more effective protection from the adverse effects of climate change on health.
- Carrying out monitoring and evaluation studies.
